## Voluntary Assumption of Risk & Release & Indemnity

(the "PAGEANT"), being put on by the band Suicide Blonde and the King's Head Pub and Eatery, whereby I will be participating in a Pageant which includes, beauty pageant, runway appearance and concert.

**I understand there are inherent risks in the Pageant which include but are not limited to alcohol, loud music, boisterous behaviour, etc. Any complications I may experience (physical or mental or monetary) during this time and after, are not the responsibility of the members of the band Suicide Blonde, or the King's Head Pub & Eatery to compensate. I agree I am of sound mind and decision for taking part in the Pageant. Any videotape and photos that may be taken during my participation in the pageant, become the exclusive right of the band SUICIDE BLONDE, and may be shown on website or other visual Media representatives.**

I represent and warrant that I am physically capable, in good medical and physical condition and that there are no factors or conditions, medical or otherwise that would affect my ability to safely participate or make a conscious decision in the Pageant which shall take place between May 23<sup>rd</sup>, 2011 and 2 a.m. July 17<sup>th</sup>, 2011. I have the requisite experience and skill to participate in the Pageant.

I understand that the Pageant entails some inherent risks, including, but not limited to, bodily harm, severe bodily injury, death, and/or other harm caused by my person, and /or other persons in connection with the Pageant. I further understand that medical services or facilities may not be immediately accessible during the Pageant. I declare that I am physically capable and have the requisite experience and skill necessary to participate in the Pageant.

I hereby voluntarily assume any and all risk of property damage to any property of any person as a result of or in connection with my participation in the Pageant, and voluntarily assume any and all risk of bodily injury, death and/or other harm howsoever caused to my person, and/or other persons, as a result of or in connection with my participation in the Pageant.

I hereby forever release and discharge, and forever agree to indemnify and save harmless, all members of Suicide Blonde and the Kings Head Pub and Eatery (hereinafter called the "Releasees", which term includes its parent successors, related, subsidiary or affiliated companies and any and all of their respective present, future and former officers, directors, agents, partners and employees and their respective heirs, executors, personal representatives, administrators, successors, and assigns) from any and all claims, actions, suits, demands, or proceedings which may be brought against the Releasees for any damages, losses, liabilities, losses, costs and expenses (including legal fees), whether caused by any act or omission of ourselves, the Releasees of any other person, and whether relating to property damage or bodily injury, death and/or other harm howsoever caused to my person, and/or any other person in connection with the Pageant.

I agree to accept and abide by all instructions given to me by the band Suicide Blonde and the Kings Head Pub and Eatery in connection with the Pageant and Pageant Mission. I agree not to do anything illegal or unlawful that would infringe the rights of any third party in carrying out the Pageant. I have read the Pageant rules and regulations and agree to comply with its terms.

I have carefully read this **Voluntary Assumption of Risk & Release & Indemnity** and declare that its terms are fully understood and given voluntarily. I am aware that this is a full and final release of any liability on the part of Releasees. I understand and agree that this **Voluntary Assumption of Risk & Release & Indemnity** is binding on my heirs, executors, personal representatives, administrators, successors and assigns.
